- 4) activation of research activities of young scientists in the field of migration at the international level;
- 5) the formation of a positive image of Russia as a country regulating migration on the basis of national legislation and interstate agreements.

#### The main issues to be discussed at the forum:

- 1. Modern migration trends in the Eurasian space.
- 2. Factors of international migration in Eurasia (socio-economic, geopolitical, demographic, natural-climatic, etc.)
- 3. The contribution of migration to the socio-economic and demographic development of the countries of Eurasia.
- 4. New approaches to managing migration in Eurasia using forecasting and modeling methods.
- 5. Migration policy of the sending and receiving countries of Eurasia and other regions of the world in new conditions.

Organizational fee for participation in conferences is not charged. Organizers do not pay for flights and accommodation, but provide organizational and visa support to participants.

<u>Working languages:</u> Russian and English; simultaneous interpretation is provided.

It is planned to publish a collection of forum materials (Russian Scientific Citation Index). Full materials for publication will be accepted **until November 1, 2018** (inclusive). The rules for the design of reports in the collection are given in Appendix 1.

It is also planned to publish special issues of several magazines of the forum participants, including those included in the list of Higher Certifying Commission and the SCOPUS base. The authors of the articles selected by the organizing committee will be notified individually.

The international youth forum "Migration and Passport and Visa Diplomacy in Eurasia" is also being held within the framework of the scientific and practical forum. It is planned to bring together young researchers in the field of migration. # **Requirements for the design of the REPORT:**

The text of the article is presented in Word format in Russian or English. The text is typed in Times New Roman font, size 14, line spacing 1.5, alignment in width. Indent of the first line is 1 cm.

The total volume of materials (including the title, annotation, key words, text, bibliography): up to 12 pages.

Figures and schemes are executed in black and white and should be of good quality. Figures should allow editing.

The text in the tables: the interval is single, size 12 TNR.

Examples of the design of tables and figures are given below.

References to sources in the text of the article are given in square brackets. Sources are listed in alphabetical order. There should be links in the text on all sources from the list of references.

Numbering of tables, figures, schemes and formulas is through.

The article should <u>obligatory</u> include: title, full names of authors, academic degree, position, place of work, email address, annotation (5 - 7 lines), keywords (5 - 7 keywords or phrases), references and sources are in **Russian and English**.




Fig. 1. Number of Russians who visited Thailand in 2007-2014, thousand people [3, p. 2]
